Order dated: 16th of August, 2024

1. On August 13, 2024, the PFF Secretariat, in compliance with the judgments issued on July 29, 2024, under Complaint No. 21/2024, and on August 2, 2024, under Complaint No. 027/2024, pertaining to the cases of "Muhammad Anwar vs. Abdul Nasir Karim Baloch and others" and "Muhammad Yameen vs. Fateh Baloch and others," submitted detailed information regarding the individuals involved in the formation of the Parallel Association. For reference, the excerpt from the judgment dated July 29, 2024, is reproduced below:

“Therefore, this Committee feels necessary to direct the PFF Secretariat to provide the details regarding the period when the Parallel Associations were formed and the name of each individual who remained part and parcel of those bodies in the past from the period of 2017 onwards as well as provide details regarding the loss to the PFF assets within a period of Three working days from the date of communication of this decision, and the separate proceedings shall be initiated by this Committee as per PFF Constitution, laws, rules and regulations.”

2. The decision that the Secretariat was instructed to comply with is divided into two parts. To keep it concise, we need to separate the judgment into these two key aspects of the case:

A. Part 1 of the Decision

“when the parallel associations were formed and the name of each individual who remained part and parcel of those bodies in the past from the period of 2017”

The period under question as the report reflects is 2018, 2019, 2021 and 2022.

B. Part 2 of the Decision

“as well as provide details regarding the loss to the PFF assets”

This section of the decision specifically addresses the circumstances surrounding the removal/loss/destruction of both immovable and movable assets of the PFF. According to the report, the following losses incurred by the PFF due to the actions of individuals involved in the parallel association are detailed below:

- a. Air-conditioning units approximately 20 were removed
- b. PKR 4 million from bank accounts
- c. Petty cash amounting to 0.2 million rupees





- d. Removal and destruction of Furniture and Fixtures amounting to approximately PKR 06-07 Million
 - e. Removal of all financial and administrative records from PFF
 - f. PFF official vehicles
 - g. Pak Rupees utilized during the period of 2018-2019 – details including audit report to be provided.
3. Further, the report reflects that in the year of 2017, certain individuals were employed under the appointed administrator, as official records are presently unavailable. Therefore, the identities of these employees cannot be ascertained, and any such individuals should be disqualified accordingly.
4. Through this order, we have identified the individuals listed below, categorized into two groups. Those involved in forming Parallel Association from 2018 to 2019 are detailed in **Annexure A**, while those implicated in the formation of the parallel association from 2021 to 2022 are included in **Annexure B**, which is attached separately. Accordingly, the Members of the PFF Disciplinary & Ethics Committee unanimously determine that a Notice shall be issued to all individuals involved in the formation of the parallel association. This Notice will be communicated via social media platforms and published on the official website. Furthermore, the Secretariat is instructed to take all necessary measures to ensure compliance with this order immediately upon its signing. Additionally, through this Notice, the PFF Disciplinary & Ethics Committee is issuing a Show Cause regarding the following points:

Why should proceedings under Article 70 of the PFF Constitution not be initiated against the individuals identified in Annex A and Annex B for their involvement in forming a parallel association and for causing loss to PFF assets during the periods of 2018, 2019, 2021, and 2022?



All Respondents listed in **Annexures A** and **B** are required to submit their written responses along-with their details which include their valid addresses; Copy of their National Identity Card Number (CNIC's) and their association with the Sporting Clubs (**If**



any) within three working days from today (16th of August, 2024), by August 19, 2024. Responses should be sent to the PFF Official Legal Department designated email provided below:

Failure to submit the response within the specified timeframe will result in the committee proceeding with the available files and records in its possession to decide on the matter accordingly.

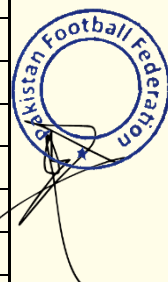

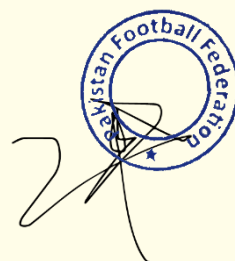

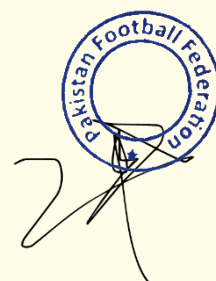
