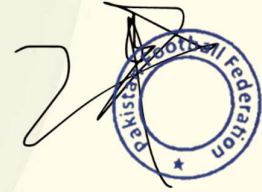

#### **Terms of the Decision:**



- a. After a comprehensive review of all relevant facts, including the Complaint referred to this committee by the PFF Electoral Appeal Committee and the Complaint submitted by the Complainant to the PFF Secretariat, the PFF is directed to conduct a thorough investigation in the event that new evidence pertaining to the current case is uncovered. This directive is issued without prejudice to other applicable legal principles, including res judicata, and guidance sought from Arbitration CAS 211/A/2625, Mohamed Bin Hammam vs. Federation Internationale De Football Association. Should the circumstances warrant, the case may be reopened to adequately examine the factual background and to determine if Mr. Muhammad Imtiaz Mirza and Mr. Zohraz Akram violated any provisions as alleged in the complaint.

## Note Relating to Appeals

- a. The aggrieved party shall communicate their decision to file an appeal in writing within fifteen (15) days of the communication of this decision.
- b. As per inter alia Article 127 of the PFF Disciplinary Code and Ethics, the aggrieved party must pay the Appeal Fees into the PFF designated bank account within seven (07) days to formalize an appeal. Otherwise the appeal is inadmissible without this deposit [Article 127(2)].
- c. Failure to do so will result in the decision becoming final and binding.
- d. The Time Limit to lodge an appeal begins upon receipt of the grounds of this decision.
