1. After reviewing the Appeal brief with the able assistance of PFF Legal Department,
the Appeal Committee of the Pakistan Football Federation has unanimously decided

to partially allow the appeal of Model Town Football Club with the reduction of Fine at the rate of Rs.30,000/- PKR to be submitted in the PFF Designated account and provide the details of the identified aggressor immediately to the PFF Secretariat within a period of Five (5) working days.

2. The sanction placed on Mr. Muhammad Raheel is modified and is reduced to the period of One Year commencing from the date of the communication of the decision passed by PFF Disciplinary & Ethics Committee and is fined Rs.10,000/- PKR to be submitted in the PFF designated bank account.
3. The appeal to the extent of Mr. Khaled Amir Khan (Coach Model Town FC) Appeal is allowed and is free from all the sanctions and fined imposed in the light of a decision dated 15th of March, 2024 passed by PFF Disciplinary & Ethics Committee.
4. The detailed reasons for this decision will be provided it is requested by the parties within a period of 10 working days.

Let the copy of this order be communicated to all the affiliated units of PFF Moreover, the PFF is also directed to ensure compliance of this order.

The PFF Secretariat, if it is appropriate, can announce and publish this decision (wholly or the relevant portion of the judgment) to the general public, on its official website or social media pages.

The PFF Secretariat is directed to submit the compliance report before the Appeals Committee.
