**VIOLATION OF THE ARTICLE 69 OF THE PFF CONSTITUTION (THIRD –  
PARTY INTERVENTION (ORDINARY COURTS OF PAKISTAN))**

**TERMS OF THE DECISION:**

- a. Following a thorough review of the facts and circumstances, the PFF Disciplinary & Ethics Committee has unanimously determined that **Mr. Muhammad Nauman (the Respondent)** is guilty of violating Article 69 of the PFF Constitution, which expressly prohibits recourse to ordinary courts.
- b. His filing a Writ Petition No. 6166 – P/2024 not only violates Article 69 of the PFF Constitution but also constitutes as interfering in the operations and activities of Pakistan Football Federation (PFF), contradicting the principles of good governance as set forth in the FIFA, AFC, and PFF Statutes.

**Article 69(2) of the PFF Constitution** is reproduced below for your reference:

*‘... Anybody going to civil / ordinary courts shall be suspended for  
5 years by PFF after going through Disciplinary proceedings.’*

- c. As a result, **Mr. Muhammad Nauman (the Respondent)** is suspended from participating in any football activities for a period of five (05) years, effective immediately.

If any of the affiliates of the PFF tried to establish contact with the individual(s) mentioned above then strict action shall be taken against them.






## NOTE RELATING TO APPEALS

- a. The aggrieved party shall communicate their decision to file an appeal in writing within fifteen (15) days of the communication of this decision.
- b. As per inter alia **Article 127** of the PFF Disciplinary Code and Ethics, the aggrieved party must pay the Appeal Fees into the PFF designated bank account within seven (07) days to formalize an appeal. Otherwise the appeal is inadmissible without this deposit [**Article 127(2)**].
- c. Failure to do so will result in the decision becoming final and binding.
- d. The Time Limit to lodge an appeal begins upon receipt of the grounds of this decision.
