FRAUDULENT CONDUCT, FORGED DOCUMENTATION AND UNLAWFUL TAKEOVER OF A FOOTBALL CLUB

TERMS OF THE DECISION:

This Terms of the Decision (C – N 30/C – A /25 (B)) adjudicates three interrelated complaints concerning football clubs affiliated with DFA Malakand. As the complaints involve the same individuals, a consolidated resolution is warranted. Each complaint is addressed individually as follows:

a. Jamil Islam Vs Muhmmad Nauman - Batkhela Eleven Football Club (Complaint No. 025/2024)

Following a comprehensive review of the relevant facts and an inquiry conducted by the Pakistan Football Connect (PFC) Team, the PFF Disciplinary & Ethics Committee unanimously concludes that **Mr. Muhammad Nauman (the Respondent)** is the rightful President of Batkhela Eleven Football Club as per the records maintained within the PFC Programme. Consequently, the allegations against **Mr. Muhammad Nauman (the Respondent)** are dismissed in their entirety.

b. Fazal Wahid Vs. Muhammad Nauman – Allegations of forged documentation & Fraudulent Activities

The complaint against **Mr. Muhammad Nauman (the Respondent)** regarding the submission of forged documents to fabricate fictitious football clubs and unauthorized use of the DFA Malakand letterhead has been examined.

The PFF Disciplinary & Ethics Committee unanimously concludes that all requisite protocols and scrutiny procedures were duly followed, and the allegations levelled by **Mr. Fazal Wahid (the Complainant)** lack credible evidence. Accordingly, the complaint is dismissed.





**c. Muhammad Nauman Vs. Jamil Islam - Sakhakot Eagle Football Club
Complaint No. 26/2024)**

The complaint filed by **Mr. Muhammad Nauman (the Complainant)** against **Mr. Jamil Islam (the Respondent)**, alleging fraudulent activity during physical scrutiny, is deemed non-maintainable. Accordingly, the complaint stands dismissed.

Should an actual dispute exist, it is incumbent upon the Club Officials of the Sakhakot Eagle Football Club DFA Malakand, to formally lodge a complaint with the PFF Disciplinary & Ethics Committee for appropriate adjudication.



Let the copy of this decision be communicated to the FIFA and AFC immediately after the signing of this decision.



NOTE RELATING TO APPEALS

- a. The aggrieved party shall communicate their decision to file an appeal in writing within fifteen (15) days of the communication of this decision.
- b. As per inter alia **Article 127** of the PFF Disciplinary Code and Ethics, the aggrieved party must pay the Appeal Fees into the PFF designated bank account within seven (07) days to formalize an appeal. Otherwise the appeal is inadmissible without this deposit [**Article 127(2)**].
- c. Failure to do so will result in the decision becoming final and binding.
- d. The Time Limit to lodge an appeal begins upon receipt of the grounds of this decision.


