
PFF Disciplinary & Ethics Committee – Decision Dated 30th July, 2025:

1. The Complaints whose details provided in the headnote have been received from various District Football Associations (DFAs) and clubs across Sindh. They are concerned about Mr. Tahir Hussain Baloch (**referred to as the "Respondent"**) being elected as President of the District Football Association (DFA) Malir while also serving as the General Secretary of the Sindh Football Association (Sindh FA). It appears that his dual roles may violate the PFF Constitution (2025). Specifically, Article 62(4) of the Constitution states:


"Article 62 – General Secretary:

4.The General Secretary may not be a Congress delegate or a member of any body of the PFF."


2. As such, the current practice contravenes the provisions of the PFF Constitution (2025). Therefore, the Federation is obliged to issue a circular instructing all Provincial Football Associations (FAs) to ensure compliance with Article 62(4). Accordingly, all appointments of individuals as General Secretaries that violate this provision must be rescinded and any decision taken in this regard by the respective secretaries to be considered in accordance with the law and no adverse notification maybe issued by the Provincial Secretaries whose decisions are not in compliance with the PFF Constitution (2025).
3. The PFF Secretariat is instructed to ensure compliance with the decision within 30 days from the date of communication of the decision.
4. *All the Complaints submitted by the Complainants are disposed of accordingly with the above-mentioned directions.*
