correspondences, and the written responses submitted by the respondents and the email of withdrawal dated 13th of November, 2025 submitted by the Complainant was duly reviewed. After careful evaluation of all relevant documents and submissions, the committee has arrived at the following decision:

- I. The Respondent No. 1 to 3 are hereby warned against recruiting or engaging any Players within the jurisdiction of the PFF without obtaining prior approval and ensuring full compliance with the NOC requirements for participation in any football activity event.
- II. The PFF is instructed to ensure that all participation by its registered or affiliated entities strictly adheres to the rules and regulations set forth by the PFF. Specifically, any representation of Pakistan in football activities must be in accordance with Article 4, 83, 84, 85 and Article 86 of the PFF Constitution (2025). They may be taken up with the relevant stakeholders with regards to the ensuring the implementation of the PFF Constitution.
- III. The allegations raised by the Complainant concerning age fraud are hereby dismissed due to the absence of credible evidence on record.
- IV. Non-compliance with the statutes and regulations of FIFA, AFC, and the PFF can lead to serious repercussions, including sanctions, disciplinary actions and de-registration from PFF platforms that may impact the involved parties' future participation in international and domestic football activities. It is imperative that all stakeholders strictly adhere to these regulations to maintain the integrity and compliance standards of the sport at all levels.

Note Relating to Appeals

- a. The aggrieved party shall communicate their decision to file an appeal in writing within fifteen (15) days of the communication of this decision.
- b. As per inter alia Article 127 of the PFF Disciplinary Code and Ethics, the aggrieved party must pay the Appeal Fees into the PFF designated bank account within seven (07) days to formalize an appeal. Otherwise the appeal is inadmissible without this deposit [Article 127(2)].
- c. Failure to do so will result in the decision becoming final and binding.
- d. The Time Limit to lodge an appeal begins upon receipt of the grounds of this decision.
